BUILDING DIVISION Highlights for Month of August

- Month of August total revenue for the Building Division was \$249,989.00.
- Building Division issued 126 Construction permits to Erect, Alter, Repair or Demolish with an estimated construction value of \$32,309,088.00for the Month of August with a fiscal year to date total value of \$38,990,120.00
- Fiscal year to date, the building division has issued new construction permits for 22 new single family dwellings, 3 two family dwellings, and 175 residential permits to add to and alter a single family dwelling, 50 new construction permits for non residential buildings and 52 permits to add to and alter a nonresidential building
- Special attention was given to fast track the Building permits for a \$942,380.00 alteration/renovation for new inpatient unit at 759 Chestnut St, \$340,000.00 new construction of a New Burger King restaurant at 400 Cooley St, \$272,000.00 new construction of a storage facility for Tibby's Harley Davidson 235 Berkshire St.
- Web site improvements, Building/Zoning went live with an interactive website posting of all daily issuance of Building, Plumbing, electrical and Sign permits for the convenience of the Business Community and general public to research or access online information.
- Building Division is also currently working on providing a user friendly on line select and file complaint system with the ability to track the current status of a filed complaint.
- An Interactive map of the City is currently under development. This will be posted on the City of Springfield Code Enforcement/Building Division's web site. This service will provide for the general public and contractors the ability to select by neighbor and address, to make contact for inspectional services with the inspector in that territory, e-mail addresses and phone numbers will be provided. This will include Building, Plumbing, Electrical, and Zoning Inspectors


- 40 Congress Street (Uncle Bob's Self-Storage). The issue of self-storage units being used as residence housing. The owner, under agreement, has immediately hired security guards to patrol the facility 24 hours a day and stop all after hour access to storage units.
- 191-193 Pine Street (Condemnation). Owner Paul Fife is making progress. Re-inspection date, September 12, 2006, next court date, September 13, 2006.
- License commission meeting held August 24, 2006, regarding seven (7) used car dealers with class II licenses. Violations range from special permit violations to zoning violations and building code violations. One property is now in compliance and extensions were granted to three (3) other properties and three (3) others did not show.
- Condemned, 35-37 Webber Street, after a fire. The tenants were provided temporary housing and we are working with the owner of the property, through the courts, to either demolish or repair this house.
