AMENDMENT #2 to CITY CONTRACT #20180082

SUBRECIPIENT PARTNERSHIP AGREEMENT WITH REGIONAL EMPLOYMENT BOARD OF HAMPDEN COUNTY, INC. FOR CONSTRUCTION SKILLS TRAINING PROGRAM

WHEREAS, on or about August 1, 2017, the City of Springfield, Massachusetts, acting by and through its Office of Community Development and Disaster Recovery & Compliance, with the approval of its Mayor (hereinafter referred to as the "City"), entered into an Agreement referred to as City Contract No. 20180082 ("Agreement") with the Regional Employment Board of Hampden County, Inc., with an address of 1391 Main Street, 2nd, Springfield, Massachusetts (hereinafter referred to as the "REB" or "Sub recipient"), to offer a Construction Skills Training Program ("Program"); and

WHEREAS, the REB will offer a Construction Skills Training Programs and a Skills Enhancement Training Program under Contract# 2018-0082, the Sub-recipient Partnership Agreement between the City of Springfield and the Regional Employment Board of Hampden County, Inc., beginning on August 1, 2017 and ending on October 1, 2018; and

NOW, THEREFORE, the parties hereto agree to amend the Agreement on the following terms and conditions:

1. The parties agree that <u>Appendix B - Scope of Services</u>, the descriptions of eligibility for the Construction Skills Training Program and Skills Enhancement Training Program are hereby amended to add language as follows:

"If, after considerable effort, the class does not fill with individuals from the target area, the class may be opened to Section 3 Residents and Businesses, whether or not the attending individuals live in the target area, as long as they were low-income individuals in the metropolitan statistical area for section 3 qualification. Further, the class may be opened to supervisors of low-income people in the target area or the MSA, because the low-income people in those areas cannot complete lead remediation without a certified supervisor on site. More than 51% of individuals trained must meet the income-qualification for the program."

2. All other terms and conditions of the Agreement shall be unaffected by this amendment and shall remain in full force and effect.
