AGREEMENT, made this 30th day of September, 2014 by and between **Viva Development, LLC**, with an address of **50 Clayton Street, Springfield, Massachusetts** (hereinafter referred to as the "Borrower") and the **City of Springfield** through its Director of Disaster Recovery & Compliance, with the approval of its Mayor (hereinafter referred to as the "City"). NOW, THEREFORE, the parties hereto agree that their Agreement shall be amended as follows:


1. **Revising the completion date of the project from October 31, 2015 to November 30, 2015. Therefore, Section 1, Paragraph B shall now read as follows:**
